The activities were discussed and the following action plan agreed:

- a. Finalise the curriculum for CLG training and publish on website: TL/ IC by 15.10.2014.
- Determine the levels of education/assessment needed to ensure safe practice of CLGs and publish document . TL/ IC by 15.01.2015
- c. Determine how those who will qualify (including those under the grandfather clause) can apply for registration and finalise all document to launch the registration process. TL/ IC by 01/06/2015.
- d. Heather Skirton encouraged the Division to hold a 2 day meeting face to face if needed to enable significant progress to be made.
- 4. Medical Professional Branch Board

A UEMS section for Clinical genetics has been established. The activities of UEMS section and EBMG medical PBB must be collaborative.

Ulf Kristoffersson suggested a route to collaboration with the UEMS.

- Board of UEMS suggests members of the medical division.
- UEMS commissions EBMG examinations according to UEMS criteria
- UEMS reviews those who qualify and approves them
- EBMG registers the applicant to for 5 years and is responsible for reregistration (according to UEMS criteria).

The following action plan was agreed:

a. Ulf Kristoffersson will send Heather the names of those who will be EBMG division members. UK by 1/10/14

- b. The division will work on the syllabus for specialist medical training including defining type and need for courses.
- c. The division will on a longer term work on a plan for re-registration of medical geneticists.
